## **PREMIO GUBBIO 2012**

### **REGULATIONS**

**ANCSA, the Italian National Association of Historical and Artistic Centers, and the City Council of Gubbio announce the “Premio Gubbio 2012”.**

**The aim of the Prize is to promote concrete advancements in working in historical areas and cities. It is open to public and private sector agencies, groups and universities, as a means of increasing their awareness of the general practices involved.**

**In considering the submissions, particular account will be given to the ability to effectively interpret ANCSA’s primary cultural and operative interests in the active conservation and regeneration of the built heritage and landscape.**

**These interests address the following areas:**

- Appropriate design of the physical, social, cultural and economic reuse of the architectural and territorial heritage, combining conservation and innovation.**
- Effective integration between future urban needs and architectural design.**
- Proposals for economic and social management of projects that are appropriate to the projects’ nature and aims.**

**Article 1 - The “Premio Gubbio 2012” is organized in the following sections:**

**1 – National Prize**

**2 – European Prize**

Open to public or private sector agencies and groups who have promoted and/or implemented plans, urban policies and projects in European countries (other than Italy) after the 1st January 2007.

**3 – National Prize for master’s and five-year degree theses, doctoral dissertations and other post-master’s degree dissertations.**

**Article 2 - Using the procedures indicated in Article 4 below, participants in the “Premio Gubbio 2012” must submit the documentation required in Article 3 to the following address:**

**Article 3** - The following documentation must be send in order to participate in the “**Premio Gubbio 2012**”:

- a) **Illustrative report**: must consist of two A4 format pages containing a maximum of 7500 keystrokes, spaces included. One hardcopy version shall be submitted together with digital versions in PDF and RTF format.
- b) **Three summary tables** in vertical DIN/UNI A1 format (84.1 x 50.4 cm) with the wording “PREMIO GUBBIO 2012” at the center (use Arial 48 pt font, top margin 1.5 cm). One DIN/UNI A3 format (29.7 x 42 cm) hardcopy version shall be submitted together with digital versions in 300 DPI PDF and JPG format.
- c) **CD ROM or DVD** containing the digital formats of the report and the three tables.
- d) **For the National and European Prizes**, the report and the tables in A3 format (in this case on the obverse side of the sheet) shall be **signed** as a guarantee of compliance by the legal representative of the promoting party and accompanied by a **letter** certifying:
  - That the documents submitted correspond to the originals, and indicating
  - The names and addresses of the authors.

The reports and the text included in the tables shall be in italian language.

Candidates for the European Prize may if desired use english language.

Additional submissions and submissions failing to comply with requirements will not be judged.

Winning candidates and those receiving mentions will be contacted by the Coordinator of the “**Premio Gubbio 2012**” before the date of the awards ceremony, and shall proceed to print the three tables on a lightweight rigid support in vertical A1 format and send them in time for the ceremony to the address indicated in Article 2 of the competition announcement.

**Article 4** - The documentation and submissions indicated in Article 3 above shall be sent in a sealed envelope bearing the following information on the exterior:

- The sender’s address and telephone number, and
- The **Prize** for which the participant wishes to compete.

The envelope shall be sent to the address indicated in Article 2 above, either by mail, by courier, or hand delivery, **no later than midday of the 28 April 2012**.

On the basis of order of arrival, the Prize Secretary will assign a sequential number to received envelopes, recording said number in a record book maintained for this purpose which will also specify the number of envelopes and the time of their delivery.

**Article 5** - The Judging Commission will be made up as follows:

**European Prize:**

- ANCSA President and Vice Presidents
- ANCSA Technical Secretary
- ANCSA International Relations Supervisor
- ANCSA Gubbio Prize Supervisor
- ANCSA Scientific Committee Coordinator

*Outside experts:*

- Joan Busquets (Spain)
- Nicolae Lascu (Romania)
- Ariella Masbounji (France)
- Yannis Tsionis (Greece)

**Article 6** - The Judging Commission will examine submissions, select the best and, no later than the 30 June 2012, will choose the winners of the prize and no more than three other candidates worthy of mention. All its decisions will be final. The “**Premio Gubbio 2012**” will be assigned to the submission which best meets the requirements of these Regulations, and will consist of a “plaque of honour” to be presented to the promoter and the individual members of the design group. For submissions receiving honorable mention, an award parchment will be presented.

**Article 7** - The Judging Commission will make clear in a report its reasons for awarding the prize and those mentioned submissions, specifying the general criteria for the selection and judgement.

A summary of the winning projects and those worthy of mention, together with the report of the Judging Commission, will be published by ANCSA.

A public meeting will be organized in Gubbio for the prize giving attended by the specialized and daily press. An exhibition will be set up to present the winning projects and those worthy of mention.

**Article 8** - Submissions sent in to the “**Premio Gubbio 2012**” will not be returned, and will be acquired by ANCSA as documentation.

ANCSA also reserves the right to publish the material received.

Participation in the Prize implies unconditional acceptance of all terms and conditions established in these Regulations.
